### HICKORY STREET HOUSE SALE - Update #2

The Congregation Council has elected to move the proceeds from the sale of the Hickory Street property out of the General Fund. The sale proceeds, \$240,000 created an unrealistic impression of funds available to the budget of Saint Matthew. It is important that the General Fund be reflective of the giving and stewardship of the Congregation. Also, the General Fund account earns no interest.

In early December, the sum of \$240,000 was transferred to Dundee Bank into designated accounts. The funds were invested in this manner: \$100,000 to a seven-month certificate-of-deposit, and \$140,000 directly to an interest- bearing money-market account. The Council is requiring that a minimum of \$50,000 remain in the money market-account. With Council approval, up to \$90,000 may be invested in stocks or bonds, in a manner generally comparable to the Endowment Fund. A number of Saint Matthew members have been advising the Council in this movement of funds.

The Council is intending to keep these funds intact, unless the Congregation should meet some profound emergency. We wish to have the full funds on hand through the call of our next Pastor. The council desires to have the vision and input of our next called Pastor prior to altering from from this stated position. The use of these funds may be subject to change in the future. The Congregation Treasurer, Financial Secretary, and full Council maintain the same oversight of the Hickory House funds as they do for any other Congregational funds.

Worship Servants help our worship gatherings function efficiently & effectively, so that we all can experience the Word of Grace in all its fullness.



- Ushers: Aid worshippers by providing direction before and during the worship, making sure that worshippers have bulletins and other supplies needed for the Sunday morning service. Ushers are the first line of hospitality.
- Communion Assistants: Assist with serving the Holy Communion elements durin ghte Sunday worship services. Special training is provided, and assistants are scheduled in rotation depending on need.
- The Altar Guild: Assists in preparation for worship and communion before services and returns unused items back where they belong afterwards. They check supply inventory, prepare font for baptisms, and wash and care for acolyte and communion assistant robes when needed. Altar Guild members work in teams of two, and are assigned two months of the year.
- Scripture Readers (Lectors): The Scriptures are His voice, and when Scriptures are read aloud, we hear God's words to his people. Lectors read aloud pre-selected passages from the bible during our worship service.
